**POSITION:** Handyman/Painter II – Full-time

**DESCRIPTION OF COMPANY:** Caritas Management Corporation (CMC) is a wholly-owned, for-profit subsidiary of Mission Housing Development Corporation (MHDC). Created in 1983, CMC now manages over 1,500 affordable housing units for MHDC and various other non-profit, community based organizations in San Francisco. The types of housing range widely, from single room occupancy hotels to apartment buildings for families and seniors. CMC's services include financial management, rent-up and ongoing leasing, occupancy & compliance, maintenance and security. Minority-owned and operated, CMC's philosophy of tenant-supportive and fiscally sound management reflects the mission and purpose of its parent company.

**SUMMARY OF POSITION:** Performs preventive & corrective maintenance, emergency repairs and ongoing upkeep of CMC's managed properties. Follows CMC's standard record keeping system for completing and tracking written work orders. "Roving" Handyman/Painter II (1 open position) reports daily to CMC's Facilities Supervisor, uses own vehicle for travel between work locations, purchases and transport supplies and equipment. "Dedicated" Handyman/Painter II (1 open position) reports to daily to on-site Building Manager, also performs preventive, corrective and emergency maintenance work per the annual Maintenance Plan and approved service requests. Handyman/Painter II skilled tasks include, but not limited to the following: minor plumbing, minor electrical, minor carpentry & painting, vacant unit turnover, occasional janitorial support, common area repairs, appliance repairs, troubleshooting, cooperating with outside contractors and responding to emergency calls after hours via pager.

- Professional building maintenance experience
- Demonstrated proficiency in the areas of plumbing, carpentry, electrical and painting
- Ability to work independently with minimal supervision; needs to be a dependable "self-starter"
